Thrive offers services in person, over the phone and through email, offering fifteen community locations to meet, covering Bend, Redmond, Madras, Prineville, La Pine, Sisters and the Confederated Tribes of Warm Springs.



Thrive is growing to meet the demand for services from Central Oregonians who have housing and financial insecurity, by linking them to creative, affordable housing solutions. **Thrive's service delivery model has shown itself to be successful, housing 186 families in the last year.**

Thrive is building its future based on our key competitive advantages:

- Our clients face no eligibility requirements
- We meet clients where they are, at locations across Central Oregon,
- We provide connections to a full spectrum of social services
- We provide comprehensive and professional case management

Thrive provides a community based social worker to facilitate engagement, resource connection and case management services, which include, but are not limited to, the following:

- Support in locating, applying for, qualifying and maintaining housing
- Completing and submitting applications for health insurance and SNAP food assistance
- Making calls and scheduling appointments with physical and mental health providers
- Submitting social security applications for those with a disability who are unable to work
- Making referrals to employment agencies and resume development
- Providing legal and support connections for individuals facing domestic violence
- Assistance in procuring items to support basic needs (i.e., food, clothing, shelter etc.)

Duties of the Board of Directors

The Board of Directors is responsible for the overall governance of the corporation and establishes policies and objectives to ensure achievement of the mission and goals of the organization. The Board also monitors progress toward organization goals and objectives. The Board reviews and takes final action on all substantive matters such as:

- Strategic planning, development of organizational goals, assessment of community needs and capacities and alignment of organizational resources
- Annual review of organization's progress toward stated goals
- Fiduciary oversight of organization financial, legal, ethical, internal policies and procedures
- Election of directors & officers
- Ratification of members of the Executive Committee
- Approval of the annual budget
- Hiring and evaluation of the Executive Director
- And more!
